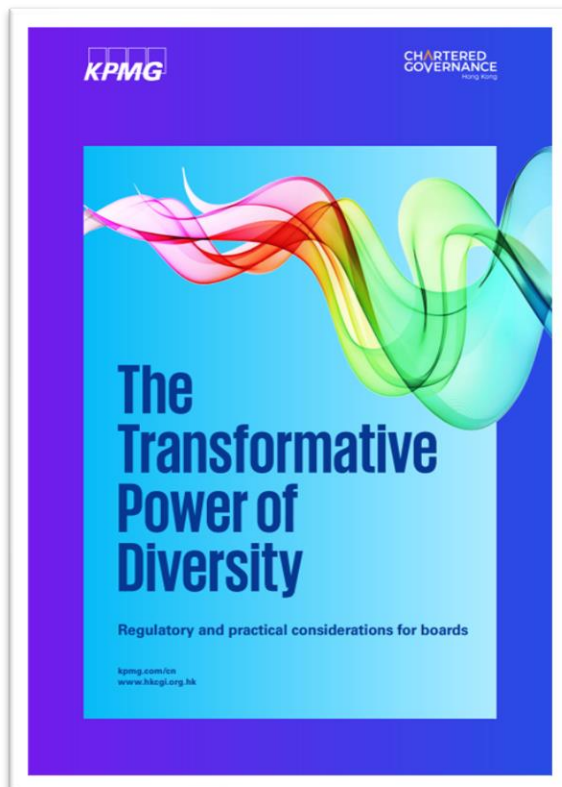
Practical Overview of HKEX's Latest Guidance on Disclosure Requirements

Wednesday 14 June 2023
3.00pm - 4.30pm

In March 2023, HKEX expressed reservations about the practice of disclosing ‘partial truths’, noting that such disclosures may also be regarded as misleading by omission.

In the hybrid seminar on 14 June 2023, Ms Stephanie Chan, Partner and Mr Adrian Tang, Senior Associate from Sidley Austin’s contentious regulatory team will provide a practical overview of HKEX’s latest guidance and enforcement trends on compliance with the disclosure requirements of the Hong Kong Listing Rules. In particular, they will draw attention to the key considerations in handling public disclosures by listed issuers and share practical tips for handling inquiries and investigations from HKEX regarding alleged disclosure failures.
