


Examination technique workshops for CGQP November 2023 examination diet

Examination Technique Online Workshops are for students with substantive knowledge of the respective modules to prepare for their examinations. The workshop will be held online from early September to late October 2023 and divided into three parts.

Parts one and two will provide an overview of the areas covered under the syllabus with key points, significant issues, examination techniques, and guidance on answering questions by using past exam papers as examples. There will be two sessions (2.5-hour workshops) and a take-home mock examination paper under these parts. In part three, students who have attended parts one and two and submitted their answers to the mock examination paper will receive feedback and guidance on how to answer the mock questions.

The enrolment period is from 24 July to 31 August 2023.


