

The Institute joined 第二屆 '一帶一路' 法律挑戰策略研討會

On 25 August 2023, Institute Vice President Dr Gao Wei FCG HKFCG(PE), Council Member Mr Tom Chau FCG HKFCG and Institute Chief Executive Ms Ellie Pang FCG HKFCG(PE) attended the seminar titled 第二屆'一帶一路法律挑戰策略研討會 hosted by the State-owned Assets Supervision and Administration Commission of the State Council (SASAC 國務院國有資產監督管理委員會) and organised together with the Ministry of Commerce (MoC 商務部) and the Hong Kong Department of Justice.

The seminar highlighted the competitive edge of Hong Kong as a platform for 'going global' and explained how Mainland enterprises could utilise the legal and dispute resolution services in Hong Kong for that purpose. Around 200 participants attended the seminar, the majority of them being representatives from state-owned enterprises and private enterprises in the Mainland.


The Law Society of Hong Kong organises a Joint Institutes Seminar
