Thanks to everyone who contributed to the success of The Hong Kong Chartered Governance Institute.

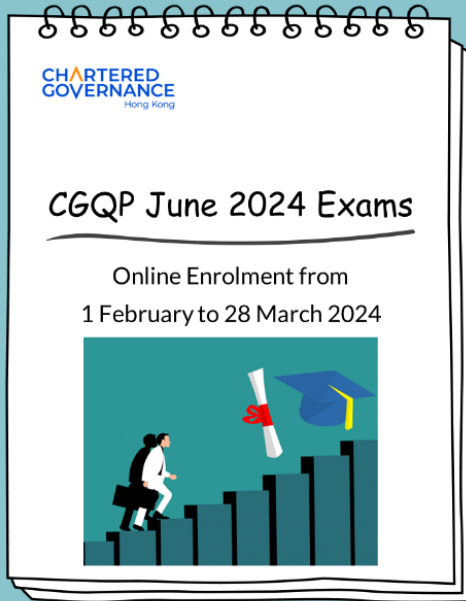
