

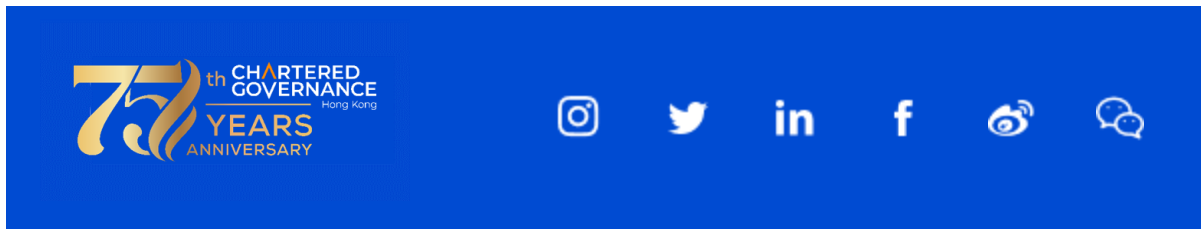
### HKIRA 10th Investor Relations Awards
