## **Corporate Governance Paper Competition and Presentation Awards**

The annual Corporate Governance Paper Competition and Presentation Awards organised by the Institute aims at promoting the importance of good governance among local undergraduates and providing them with an opportunity to research, write and present their findings and opinions on the selected theme.

This year's theme is 'Overcoming Governance Obstacles in NGO Administration'.

Current undergraduates of all disciplines in Hong Kong are eligible to enrol for this Competition in a team of two to four members. Each enrolled team is required to submit a paper on the theme of not more than 5,000 words in English. The six finalist teams will present their papers on Saturday 7 September 2024 to compete for the Best Presentation Award and Audience's Favourite Team Award.



## About the theme – Overcoming Governance Obstacles in NGO Administration

This year's focus emphasises a crucial sector in our effort to promote good governance practices: nongovernmental organisations (NGOs). Organisations that manage social impact, such as NGOs, are essential to different communities. However, recent events highlight how important it is for NGOs to have strong governance structures. To discuss effective governance, participants are encouraged to submit case studies that shed light on NGOs' difficulties. It is recommended that participants explore the intricacies of overseeing a variety of stakeholders, maintaining openness, and resolving issues that may emerge in these crucial organisations.

### A large number of stakeholders

Examine the dynamics of overseeing a diverse group of stakeholders, such as the general public, volunteers, beneficiaries, and contributors. Examine how different stakeholder expectations and interests can be balanced by effective governance.

### Accountability and Transparency

Consider how crucial it is for NGO operations to be transparent, particularly regarding financial reporting and administration. Talk about the accountability systems that can foster stakeholder trust.

#### Case Studies in the Governance of Nonprofit Organisations

Examine actual case studies that illustrate the governance difficulties that non-governmental organisations confront, such as current events. Make suggestions and offer fixes based on the knowledge gained from these situations.

## **Rules and regulations**

### Eligibility

Local undergraduates in Hong Kong in a team of two to four members.

## Paper guideline and requirements

- 1. Teams are required to:
  - a. read and follow the HKCGI writing style guide; and
  - b. state a bibliography at the bottom of the relevant page(s) and at the end of the paper, if made.
- 2. Teams are NOT allowed to put any group member or university/institution name(s) etc. for identification purpose in all pages except the cover page of the paper.
- 3. Topic and word count of the paper should be included in the cover page.
- 4. Footnote or bibliography will not be counted in the word count of paper.
- 5. Each team is required to submit the below on or before the deadline (Sunday 9 June 2024):
  - a. the paper: no more than 5,000 words in English;
  - b. executive summary: no more than 100 words in English; and
  - c. photo(s) of each team member.
- 6. The paper, executive summary and photos should be saved in separate files with the following format:
  - a. the paper: CG Paper 2024\_[team leader's name];
  - b. executive summary: Executive summary\_[team leader's name]; and
  - c. photo: photo\_[full name] (e.g. photo\_Chan Tai Man)



- 7. Team will be disqualified if:
  - a. they provide with HKCGI any incorrect or false information; and/or
  - b. their submitted paper has infringement of any copyright of any third party\*
    - \* Plagiarism is a serious academic offence and all papers suspected of the same shall be disqualified at the absolute discretion of the reviewers or judges.

### Photographs, video, sound records

This Competition shall be photographed, filmed and/or sound recorded, and all images and sounds (include any identifiable images and sounds of participants) will be used by HKCGI.

## Publication

The Best Paper shall be published in the HKCGI monthly journal, <u>CGj</u>, together with the first and second runners-up papers publish in the Booklet of the Competition, and other HKCGI publications and social media platforms.

## **Reviewers and judges**

- 1. A team of 10 to 15 academics from universities to review the papers.
- 2. A three-member panel judges who are governance professionals to review the six-finalist's paper and determine the Best Paper Award, first and second runners-up of the Paper Competition.
- 3. Another three-member panel judges from the profession to determine the Best Presentation Award on the presentation day.
- 4. The audience on the presentation day to vote and determine the Audience's Favourite Team.

## **Prizes and Awards**

Decisions of the judging panels and the votes of the audience are final.

All teams will receive a certificate of participation. The prizes and awards of the Competition cannot be exchanged.
