## **Terms & Conditions**

1. An Corporate Package holder is entitled to attend a fixed number of The Hong Kong Chartered Governance Institute ("HKCGI") regular seminars (1.5/2 hours)¹ held within the 2024/2025 CPD year prescribed in the below table, including the Annual Corporate and Regulatory Update (ACRU)², but excluding the Corporate Governance Conference, government funded seminars, seminars organised jointly with other institutions and seminars for Board Secretaries of the Mainland, seminars explicitly excluded by HKCGI and HKCGI ECPD Videos on Demand.

- 5. The Corporate Package for Practitioner's Endorsement ("PE") can only be used by PE holders in the current CPD year.
- 6. Company web account:
  - a) A designated company web account will be assigned for the use of Corporate Package, you will received an activation email from HKCGI to activate your web account.
  - b) You are responsible for informing us of any changes to the information you have provided, including but not limited to company name, contact person information and company web account login email address.
  - c) You are required to complete the online registration procedures to secure a place for your employees for each seminar on a first-come first-served basis. Once the enrolment is confirmed, NO REFUNDS/CANCELLATIONS/ALTERNATES will be entertained.
