1. Notes:

- a) The holder of Director Training Company Package is entitled to enrol the pre-recorded director training programmes by utilising the specified number of units for the directors of the company within 12 months from the date of purchasing the package.
- b) One unit will be deducted from the Director Training Company Package for one 1.0-hour or 1.5-hour director training programme by one director.
- c) Two units will be deducted from the Director Training Company Package for one 2.0-hour or 2.5-hour director training programme by one director.
- The Director Training Company Package is not applicable in the Forthcoming ECPD seminars, Annual Corporate and Regulatory Update (ACRU), Corporate Governance Conference (CGC), Certification Courses, government funded seminars, seminars organised jointly with other institutions, and seminars organised in Chinese Mainland, seminars explicitly excluded by HKCGI, and any other pre-recorded programmes not specified for director training purpose.
- 3. The Director Training Company Package is valid within 12 months from the date of purchase. Unused units, if any, will be lapsed upon expiry of the 12-month period. No application for extension will be entertained.
